The Five Cities Senior Transportation Project is for those 60 and over.

The purpose of the program is to provide the senior citizens of Brooklyn Center, Crystal, Golden Valley, New Hope and Robbinsdale with transportation to city-sponsored activities, congregate dining, social services and to major shopping centers

RESERVATIONS: To reserve or cancel bus call (763) 531-1259, Monday-Friday 8:00 a.m. – 3:00 p.m. Please be ready to be picked up at the times listed. Lift equipped vehicles are available upon request. **Home pick-ups** are available in both Crystal and New Hope.

DRIVER ASSISTANCE POLICY: If riders want driver assistance when boarding or exiting the bus, **wait for the driver to help you!** You will need to allow riders who do not want assistance to board or exit before you receive help.

FARE: The fare is \$3.50 with the handy punch pass or \$4.00 cash. Punch passes will be available in \$14 or \$28 amounts and can be purchased from the drivers with cash or a check made payable to: First Transit.

Note: Special Destination Fare is two punches from the bus pass or \$7 cash fare for round-trip transportation with 5 Cities.

No one will be denied service if unable to pay the fare.
