The Five Cities Senior Transportation Project is for those persons 60 years of age and older. The purpose of the program is to provide the senior citizens of Brooklyn Center, Crystal, Golden Valley, New Hope and Robbinsdale with transportation to city-sponsored activities, senior dining, and to major shopping centers. Make a reservation at least 24 hours in advance by calling the direct reservation line – 763-531-1259 between 8:00 A.M. AND 3:00 P.M. Riders may reserve as many rides as they wish for June and may register for July 2009 reservations the last week of June. Visit us at: www.5citiesmn.org

RIDER ASSISTANCE POLICY: Five Cities drivers will assist riders boarding or exiting the Five Cities bus. If you want assistance WAIT for the driver to help you. You may need to allow riders who do not want assistance to board or exit before you receive help. Ask the driver or signal that you would like assistance. WAIT until the driver has exited the bus and is standing by the door. A passenger lift is available if the stairs are difficult for you.

FARES: The fare per round trip ride is \$3.50 with Punch Pass or \$4.00 cash. Punch passes are available in \$14 or \$28 amounts and may be purchased from the Five Cities drivers with cash or with a check made out to First Transit Company.

FARE FOR SPECIAL DESTINATIONS: Special destination fare is 2 punches from the punch pass or \$7 cash. These programs made possible in part with a generous contribution from Humana.

PHARMACIES, POSTAGE, AND BANKING OPPORTUNITIES ARE ALSO AVAILABLE AT MANY FIVE CITIES DESTINATIONS.
